Executive Summary

A programme of meetings for the Combined Fire Authority (CFA) for 2018/19 and 2019/20.

Recommendation

The Authority is asked to agree the programme of meetings for 2019/20 as set out in the report now presented, and agree to delegate authority to undertake budget consultation to the Chairman, in consultation with the Treasurer and Chief Fire Officer.

Information

At the meeting of the Combined Fire Authority held on the 19th June 2017, the CFA agreed a programme of Meetings for 2017/18 and 2018/19.

It is now necessary to agree a programme of dates for 2019/20.

In considering suitable dates, the following points have been taken into consideration: -

- i. A preference previously expressed that meetings of the CFA be held on Mondays commencing at 1000 hours at the Training Centre, Euxton.
- ii. Standing Order No 2.2 of the CFA which states that the Authority must hold an Annual Meeting between 1st April and the 30th June each year.
- iii. Standing Order 2.3a of the CFA, which states that a programme of meetings for the Authority should be determined annually by the Authority and additional meetings of the Authority held as determined by the Authority or at the discretion of the Chairman.
- iv. Previous concerns raised by Members about initial consideration of the draft budget at the December meeting, prior to the draft Local Government Finance Settlement announcement. As such the Authority has three options:-
 - Continue with current system, reporting a draft budget in December and authorising consultation on this, despite the lack of the draft settlement, followed by the main budget meeting in February;

- Hold an additional CFA meeting in early January, following release of the draft Local Government Finance Settlement, for Members to give initial consideration to the draft budget and authorise consultation on this, followed by the main budget meeting in February;
- Delegate approval to undertake consultation on the budget to the Chairman in consultation with the Treasurer and the Chief Fire Officer. This maintains Members' involvement but enables consultation to take place prior to main budget meeting in February. In essence this would mean moving to just one budget meeting in February, at which Members will consider and agree a final budget and the resultant council tax implications.

Historically the Authority has received very few responses to its budget consultation process, hence delegating approval to undertake consultation to the Chairman, Treasurer and Chief Fire Officer is the preferred option.
