NOTES OF PREVIOUS MEETING

The Chairman, Councillor D Smith welcomed the Members to the meeting. He expressed his thanks to Members for their contribution during the year and gave best wishes to County Councillor Ron Shewan who would be retiring at the forthcoming County Council election.

The notes of the previous meeting held 9 November 2016 were confirmed as a correct record and signed by the Chairman.

REVIEW OF MEMBER TRAINING AND DEVELOPMENT STRATEGY
